



webEdition Licence agreement

1 Licence agreement

By placing an order for webEdition through our Internet page www.webedition.de you have taken note of and accepted the license agreement. In addition to this, for your information, the license agreement is also included as a PDF document in the files which you download from the Internet or which are included on the CD of the software package.

1.1 Right of use and enjoyment

webEdition Software GmbH shall grant you the simple, non-exclusive right to install and to use the software program (hereinafter known as webEdition) on a (Basic version) five (webEdition FIVE) or twenty (webEdition TWENTY) domains as well as all acquired additional licenses, as well as to allow third parties to use the webEdition installed by you. You will continue to be allowed to assign an installed domain to a third party. This includes passing over the entire risk to the third party. Notification to this effect shall be required by webEdition Software GmbH, so that we can amend the data bank entries. Then one domain shall be subtracted from the number domains to be installed by our customer. Sources (Original download or CD, as well as copies of them) must not be passed on.

1.2 Copyright protection

webEdition is protected against unauthorized copying by the law on copyright, international agreements and other national laws. You may only make a single copy of webEdition and use it solely as a back-up copy or for archiving purposes. Neither the manual nor any other written material on webEdition may be copied or reproduced by other means without the express and written permission of webEdition Software GmbH.

1.3 Renting, loan, assignment

You must not rent out, loan or assign webEdition in whole or in part, or copies of it. Nor may licenses may be transferred to third parties. The licensee shall always be the buyer, regardless of any third party rights of use and enjoyment there may be.

1.4 Other restrictions

As a matter of principle you shall be entitled to modify webEdition or to integrate it into another system. Should such modifications or integration constitute a breach of third party proprietary rights, no claims can be asserted against webEdition Software GmbH. Under such circumstances you will have to indemnify webEdition Software GmbH against all claims. In addition to which all alterations to the source code as well as all other developments of webEdition shall pass over to the unlimited right of use and enjoyment of webEdition Software GmbH. The licensee shall be obliged to notify webEdition Software GmbH of all modifications to the source code of webEdition directly and without delay, and to allow it access to the modifications. All rights– including those to the modified source code shall remain with webEdition Software GmbH.

1.5 Guarantee

webEdition Software GmbH shall give a guarantee for a period of 90 days from the date of invoice that the software will essentially function in accordance with the information in the manual. It should be noted that it is not possible to develop computer programs which are free of defects for all servers – and for all browser

conditions. This guarantee is limited to 90 days and shall be given by webEdition Software GmbH as manufacturer and shall expressly not apply to missing or faulty product characteristics occurring as a result of using specific browser versions. We recommend Microsoft Internet Explorer, version 5.5 or later.

1.6 Claims under warranty - Remediating defects – Liability for subsequent damage

Improper treatment or modifications to webEdition shall exempt webEdition Software GmbH from any warranty claims whatsoever. Notification shall have to be given straight away of any identified defects, which are not understood by customer service staff or which cannot be rectified by them; in any case such notification shall have to be given within the warranty period.

In the case of an individual adaptation, provided that a product feature was agreed by webEdition Software GmbH when it was commissioned, if the end product does not actually have it, it is possible to demand that the defect be remedied.

Moreover, the need for a remedy has to be clarified in each individual case. No fundamental right will be granted for a defect to be remedied.

Notified defects which cannot be traced even with a careful check, or which were not notified straight away shall release webEdition Software GmbH from its obligation to remedy the defect.

Compensation claims for damage of all types, including damage as a result of using the software on data, software or hardware, are ruled out. This shall apply in particular to damages caused by lost profit, losses from interruptions to operations, the loss of data or from other financial loss.

Liability for consequential damage is in any case limited to the amount that you actually paid for webEdition.

The liability restrictions shall not apply for warranted qualities and damages that result from intentional or gross negligence by webEdition Software GmbH or on a breach of fundamental contractual obligations. The claims based on mandatory statutory product liability rules shall also be unaffected by limitations on liability. webEdition Software GmbH advises that the recommendations for the installation and use of webEdition should be read through carefully and adhered to. In addition to this, webEdition Software GmbH recommends that back-ups of your application should be created on a regular basis.

1.7 General provisions

This agreement shall be governed solely by German law. The place of jurisdiction shall be the courts having jurisdiction where webEdition Software GmbH is based in Karlsruhe.
